RULES

PURPOSE

The Sampley-Conn Violin Scholarship is named for a former OFMC member and Past President, Margaret Conn. By donation, OFMC has been able to distribute cash award scholarships in the area of violin in order to encourage high school and college students to continue in their studies of stringed instruments. Awards are made to students for outstanding performances specifically in the category of Violin.

ELIGIBILITY

1. Applicants must be native-born or naturalized citizens of the United States of America. An attested facsimile or photocopy of birth certificate, passport or naturalization papers must accompany each individual's application. **A driver's license is not acceptable as proof.**
2. Applicant must be an Oregon resident and currently studying with an OFMC teacher, and/or registered as an OFMC Student Special Member
3. Applicant's age must be 16-22 as of March 1 of the Scholarship year.
4. Teacher supervision of repertoire required
5. Applicant must prepare a well-balanced, completely memorized program.
6. Winners shall perform at OFMC year-end Meeting or Conference in June.

REQUIREMENTS - REPERTOIRE

1. Selections: one **Baroque** (complete work or movement); one **Classical** (complete work or movement); one **Romantic or Impressionistic** (complete work or movement); and one short **Contemporary** work by an American Composer (complete work or movement). One movement of a **Concerto** from standard violin literature (will fulfill one of the above requirements).
2. The Applicant must furnish all accompanists. Use only legal publications (*no photocopied music allowed*).
3. **Twenty-five (25) minutes will be allowed for each audition.** Applicants will choose the first selection. Judges may stop contestants during performance. The judge(s) reserve the right not to select a winner if no candidate is deemed qualified. There will be no ties.
4. The decision of the judge(s) is final.
5. All applicants must **provide one legal copy of each selection for the judges' use.**
6. *Photocopied music will result in automatic disqualification.*
7. Twenty-four (24) hours' advance notice to the Scholarship Chairman is expected in cases of cancelled auditions.
8. The nonrefundable application fee of \$15.00 should be made payable to: *Oregon Federation of Music Clubs.*
